

Smartphones have become central to our digital lives. We use them to connect with our friends and family, and to access information, entertainment, and markets. With competition enforcers increasingly intervening in digital markets and regulatory authorities examining many of the issues that can arise within them, it's vital to understand how the smartphone ecosystem generates value for society.

Google asked Oxera to consider the benefits that the Android ecosystem brings to consumers, businesses, and digital markets in Europe. We found that Android plays an important role in the European digital economy as a multi-sided platform that brings businesses and consumers together across a range of devices.

Android's success rests on creating a virtuous circle of growth by stimulating both 'sides' of the market. Increasing the number of users attracts app developers and service providers, who in turn attract more users, and so on. This virtuous circle is possible because of a number of key product design and business model decisions that Google made.

Mastercard

We advise Mastercard on regulatory competition investigations, acquisitions, and litigation. In doing so, we combine our core skills (competition economics, finance, data analytics, and behavioural economics) with creative thinking to deliver innovative and practical solutions.

Using its technological know-how, Mastercard develops, operates, and maintains a payment network that enables companies to do business with consumers conveniently and securely—whether a transaction involves buying groceries online or paying for a new car at a dealership.

The economics of payment systems is fascinating; it involves network effects, a two-sided market, and a four-party model where the operator (Mastercard) sets the rules and provides the incentives for the four parties—issuers, acquirers, cardholders, and merchants. These rules and incentives mean that the parties work together to ensure that money moves in a secure, timely, and convenient way.


Experience so far




So far I've gained..
