Profile

Giulio has over 20 years' experience as a professional economist in the field of competition policy and energy, including ten years as an economics consultant in the private sector and around 12 years in the European Commission.

During his time at the European Commission, he was Head of Unit in the Chief Economist Team of DG Competition, where he led the economic analysis on numerous merger investigations (including over 25 Phase II mergers) and on several antitrust matters in the energy, pharmaceutical and digital sectors. He was also Deputy Director and Head of Unit in the taskforce managing the funds of the Recovery and Resilience Facility (Next Generation EU), with responsibilities for the energy and environmental aspects of the Facility, as well as for the Spanish Recovery Plan.

He has been an external faculty member of the Barcelona Graduate School of Economics since 2007, and was the President of the Association of Competition Economics in 2014 and 2015. He was also a Research Fellow at IESE Business School between 2007 and 2011.

He holds a DPhil in Economics from the University of Oxford (Nuffield College). He has published several academic and policy papers in the field of competition policy and energy (including articles in the International Journal of Industrial Organization, the Review of Industrial Organization, the Journal of Regulatory Economics, and the National Bureau of Economic Research).
